

GENERAL POPULATION ALLOWABLE ITEMS

ANYTHING not on this list must be purchased on canteen, or they are subject to being discarded upon retrieval

Visitors have three days from the time the individual is booked into the facility to bring the allowed items. After three days, property may ONLY be dropped off on Monday's during business hours. Property can be mailed in any day at the following address:

- LEGAL MAIL (NO LIMIT, BUT MUST FIT IN PROPERTY BOX DUE TO FIREHAZARD REASONS)
- ENVELOPES (PRE PRINTED STAMPS)
- LOOSE LEAF WRITING PAPER (SEALED IN ORIGINAL CLEAR PLASTIC)
- 6 WHITE T-SHIRTS (NO LONGSLEEVE)
- 6 PAIRS WHITE SOCKS (GRAY ON THE BOTTOM OF FOOT IS ACCEPTABLE, BUT NO MORE)
- 6 WHITE UNDERWEAR/BOXERS
- 6 WHITE BRAS (FEMALES ONLY – NO WIRE)
- ALL WHITES IN ORIGINAL PACKAGING OR TAG STILL ATTACHED
- BIBLE (NO PLASTIC TABS OR DIVIDERS, NON HARDBACK)
- READING GLASSES (MAX 1 PAIR)

The following property items CANNOT be dropped off to the facility

- READING MATERIAL (MUST BE MAILED TO ABOVE ADDRESS – HARDBACKS OR X-RATED WILL BE REJECTED)
- PICTURES (MUST BE UPLOADED VIA SMARTJAILMAIL FOR ELECTRONIC VIEWING)
 - Pictures must not be offensive, which includes;
 - No gang related or can be interpreted as gang related
 - No Nude photos
 - No bathing suit photos unless on a beach or by a pool (NOTE: If bathing suit is too revealing the photo may still be rejected)

The following items will be issued by the facility to the individual

- HYGIENE ITEMS
- BEDDING
- UTENSILS
- SHOWER SHOES
- LAUNDRY BAG
- PROPERTY BOX

NOTICE!! PLEASE READ!

Any items mailed in OR dropped off that is not allowed, those items will be discarded due to the inability for the facility to pay for return shipping/store said items. This also applies to EXCESS ITEMS, which will also be subject to disposal

It is the responsibility of the incarcerated individual to ensure that he/she has space in their property box for said items, otherwise, the individual will have to discard the property by one of the three ways listed:

- Taking it upon themselves to mail it out via US postal mail. To do so, they must request from administration approval for a pre-paid box to be mailed to above address. The individual will have ONE day from box arrival to pack up what they would like to mail
- Filling out a property release and having someone pick up said property. They must state in property release that property is in their possession, specifically what they want to release, and who they want to release it to.
- Throwing away the property themselves.

NOTHING will be taken by officers to be placed in property room due to limited space
