NOTICE!! PLEASE READ!

Any items mailed in OR dropped off that is not allowed, those items will be discarded due to the inability for the facility to pay for return shipping/store said items. This also applies to EXCESS ITEMS, which will also be subject to disposal

It is the responsibility of the incarcerated individual to ensure that he/she has space in their property box for said items, otherwise, the individual will have to discard the property by on of the three ways listed:

- Taking it upon themselves to mail it out via US postal mail. To do so, they must request from administration approval for a pre-paid box to be mailed to above address. The individual will have ONE day from box arrival to pack up what they would like to mail
- Filling out a property release and having someone pick up said property. They must state in property release that property is in their possession, specifically what they want to release, and who they want to release it to.
- Throwing away the property themselves.
