## LAMAR COUNTY JAIL: PROPERTY, CANTEEN, VISITATION INFORMATION

**CANTEEN**: You can deposit funds onto an individual's account with three methods

- PHONE: Fees as low as \$3.95 CALL 1-866-345-1884
- ONLINE: Fees as low as \$2.95 GO TO WWW.ACCESSCORRECTIONS.COM
- MONEY ORDER: \$3.00 Processing Fee Mail to the following address, making sure to include the facility's name, the individual's name, and their ID# (this can be found using the inmate search option on **sheriff.lamarcountyms.gov**)

Please note that this money does not go towards Remote visits, however the inmate can choose to transfer CANTEEN funds to their PHONE account. Phone funds CANNOT be transferred, only canteen.

**PHONE:** You can deposit funds onto an individual's phone account with two methods

- PHONE: CALL 1-877-618-3516
- ONLINE: GO TO WWW.CSGPAY.COM
- Remember, funds deposited on the CANTEEN ACCOUNT above can be transferred at will by the incarcerated individual to their phone. This DOES NOT WORK the other way around.
- One free 5 minute phone call is issued to everyone weekly on Monday's
- INMATE DEBIT is their account to call anyone they choose. The other option is to put the funds on your account, paying for phone calls only to your registered number.

**VISITATION:** To register for visitation, visit <u>WWW.JAILATM.COM</u>. On this website, you can make remote visits in video form. These visits can be purchased from your end without transferring funds onto the individual's account.

This site will also allow you to purchase messages that can be used towards an instant messaging system. This works similar to emailing.

- For remote visits it is recommended to use a computer rather than a cellphone. Although a cellphone can be used, if the phone loses signal the visit may be lost.
  - One free remote visit can be used weekly. Free visits go into effect on Sunday's.
  - After you create your account, select the visitation tab and search the inmate by name. If the free visit is available, it will show you on the left of the screen. Select "VISIT NOW" to begin your visit.
  - SCHEDULED VISITS ONLY WORK ON SITE (AT THE LAMAR COUNTY JAIL) WHERE YOU WILL USE A KIOSK IN THE CANTEEN OFFICE TO PERFORM YOUR VISIT. THIS IS NOT A CONTACT VISIT SCHEDULING

**MAILING ITEMS TO LAMAR COUNTY JAIL:** All non-allowed items that are mailed in will be discarded due to inability to pay for return shipping, or store said items. Please confirm allowed items before mailing anything to be sure. For questions about allowed items, please refer to the bottom of the page for the contact information.

 This mail will then be scanned (envelope included) onto the individual's kiosk account to be viewed electronically. ANY physical mail will be returned to sender if it is not Legal, Religious, or a package of physical property.

**DROPPING OFF PROPERTY:** Whites, glasses, and bibles may be dropped off within THREE days of the individual's booking. After three days, all property must be mailed in (any day) or dropped off on Mondays ONLY. Books CANNOT be dropped off, and must be mailed in.
